



It's Your First Visit—Welcome!

When you arrive at our office you will be greeted warmly by our staff, who are exceptionally well trained and were hand-picked for their commitment to customer service. Their first priority is to help you have a comfortable experience. They will help you fill out the initial paperwork, answer your questions and explain our fee structure.

Soon after you have filled out the initial paperwork, you will have a private meeting with Dr. Groulx to discuss your health concerns. There is no doubt you will find Dr. Groulx to be warm, personable, a "straight-shooter" and a great listener. He is also a top-notch chiropractor who counts several chiropractors from the Ottawa area among his client base. 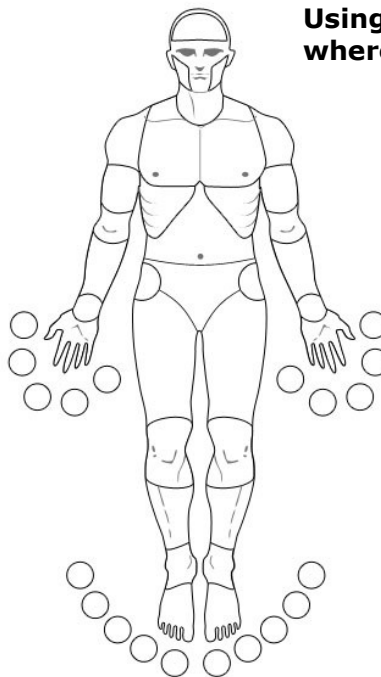
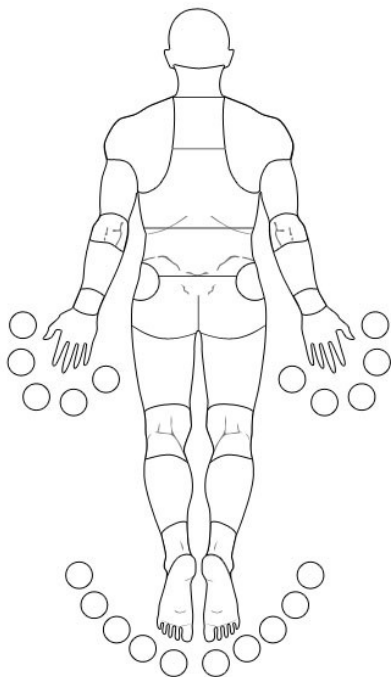
